


Foreword

Friend of the Sea is a non-governmental organization, which was established in 2008. Its aim is to safeguard the marine environment and its resources by incentivising a sustainable market and implementing specific conservation projects.

Requirements are classified as Essential or Recommendations, according to their level of importance.

Essential Requirements: 100% conformity to essential requirements is mandatory in order to be certified. The company has to propose effective corrective actions (declaration of intents and implementation plan), to be submitted to the certification body within three weeks from the issuing of the non conformity. This proposal shall also include a timetable concerning the implementation of each corrective measure. Each proposed corrective action shall be fully implemented within the following 12 months and verified during the surveillance audit.

Recommendations: Compliance with recommendations is not mandatory for the company to be certified. However, compliance with recommendations will be verified during the audit and any deficiency will be included in the Audit Report as a recommendation. The company shall inform the certification body, during the following audit, regarding any corrective measures implemented.

Notes to the auditor

- 1)** The auditor shall fill out all fields in the checklist.
- 2)** Checklist compilation guidelines are highlighted in the blue boxes.
- 3)** The Auditor shall provide an explanation when requirements are not applicable.
- 4)** The Auditor shall write YES when the unit of certification complies with a requirement and NO when it does not.
- 5)** The Auditor shall comment and explain the positive or negative answers. Mere "YES," "NO," or "N.A." are not considered as sufficient and additional certification will be requested.
- 6)** Each relevant document shall be added to the final audit report in a separate and numbered attachment.
- 7)** Photographic and videos added to the checklist or attached can represent valid onsite evidence.

3 - Boats authorized location and approach

3.1	In the area between 300 m (984 ft) to 100 m (328 ft) from the cetaceans (i.e. the 'Watching Zone'), boats shall keep a slow and constant no-wake speed (≤ 5 knots). Chasing whales and dolphins is not permitted.	Essential	Procedure and evidence of conformity.		
3.1.1	When dolphins and whales approach the boats while cruising, the boats shall keep the same speed and do not change direction.	Essential	Procedure and evidence of conformity.		
3.2	Except when cetaceans approach the boats, boats shall always maintain themselves at a minimum distance from the cetaceans. The minimum distance is 100 m (328 ft) from whales and 50 m (164 ft) from dolphins (Watching Zone). A shorter distance is prohibited.	Essential	Procedure and evidence of conformity.		

3.3	The boats never intentionally approach cetaceans head on or from the rear. The approach must begin with an inclined route of approximately 30° with respect to the route of cetaceans, to become gradually parallel to their route.	Essential	Procedure and evidence of conformity.		
3.4	Care shall be taken to make sure that no pod is dispersed, nor calves and juveniles are separated from their mothers.	Essential	Procedure and evidence of conformity.		
3.5	The boats shall not intentionally approach isolated mothers, calf/juveniles' pairs, isolated calves/juveniles, mating cetaceans nor cetaceans which appear to be resting or avoiding boats.	Essential	Procedure and evidence of conformity.		
3.6	Only one boat at the time can be in the Watching Zone while the others must wait outside (over 300 meters).	Essential	Procedure and evidence of conformity.		
3.7	Time in the Watching Zone shall be limited to thirty minutes. It is reduced to 15 minutes if there are other boats waiting.	Essential	Procedure and evidence of conformity.		
3.8	Engines shall be placed in neutral when boats stop in the Watching Zone.	Essential	Procedure and evidence of conformity.		
3.9	The crew is aware of the position of the cetaceans at any time, in order to avoid collisions or getting too close to the cetaceans.	Essential	Driver must wait for cetaceans to return to the surface from a dive to be sure of their position.		

4 - Special Considerations for Sperm Whales

4.1	When a sperm whale abruptly changes its orientation or starts to make short dives of about 1 to 5 minutes duration, without showing its tail flukes, the boat shall leave the Watching Zone at a no-wake speed (≤ 5 knots). until outside of the approach zone and always monitor the sperm whale's position to avoid accidental collisions. 6.5	Training programs for operators and crew on the biology and behavior of target species and on responsible dolphin and whale watching operations are carried out.	Essential	Training and courses planning and content. Certificates of attendance.
